

#### **MOISTURE DISCOUNTS**

- Drying charges are \$0.045 per point of moisture removed to 16%
- Anything below 16%
  moisture will not accrue a
  discount

Moisture grades will not be averaged

# FOREIGN MATERIAL & DAMAGE DISCOUNTS

- Foreign Material
  - 3% 4% → -\$0.04/bu
  - $\circ$  4.1% 5%  $\rightarrow$  -\$0.08/bu
  - $\circ$  5.1% 6%  $\rightarrow$  -\$0.12/bu

Anything above 6% will be subject to rejection

- Damage
  - $\circ$  5.1% 6%  $\rightarrow$  -\$0.01/bu
  - 6.1% 7% → -\$0.02/bu
  - 7.1% 8% → -\$0.04/bu
  - 8.1% 9% → -\$0.08/bu
  - 9.1% 10% → -\$0.12/bu

Anything above 10% will be subject to rejection

#### **SHRINK DISCOUNTS**

1% shrink per point of moisture removed to 16% Shrink grades will not be averaged

This schedule is subject to change at any time without notice.

## TEST WEIGHT DISCOUNTS

- 53 53.9  $\rightarrow$  -\$0.01/bu
- 52-52.9  $\rightarrow$  -\$0.02/bu
- 51 51.9  $\rightarrow$  -\$0.04/bu
- 50- 50.9  $\rightarrow$  -\$0.06/bu

Anything under 50 is subject to rejection

#### PRICE LATER CHARGES

- \$0.20 per bushel maximum through January 31st,
  2026 with \$0.03 per bushel per month through July
  31st, 2026.
- Must be priced by July 31st, 2026.
- If not priced by July 31st, 2026, corn will be priced at the close of that day.
- Please call before delivering corn on Price Later.
- Price later corn cannot be applied towards a forward sale contract and cannot be forward sold.
- Title of grain passes to buyer upon delivery.
- Pricing must be done during CME trading hours and at buyer's posted nearby bid.

### STANDARD POLICIES

Moisture and shrink grades are NOT averaged by load.

If you haven't hauled to us before, give the office a call so we can set you up with an account!

Please notify the office before hauling grain if you would like to defer your payment to the following January.

Please notify the office and scale operator concerning owner and split percentages.

Corn delivered without contract will be spotted at the end of the day, unless prior arrangements have been made.



New Fashion Pork reserves the right to reject any corn that is found to be musty, heat damaged, sour, or has a commercially objectionable foreign odor (COFO). This includes fumigated corn (no pellets or residue). Loads with two or more live weevils are considered infested and will be rejected
